**CALL TO ORDER**

**TREASURER'S REPORT**

Sandy O'Brien was awarded IACTE Teacher of the Year and Roger Foelske received the award for Lifelong Honorary Membership.

July had a leadership retreat—discussed joint conference. On board with 2012 joint conference. Still in discussions on the dates.

Dave Bunting has recently been elected Region 3 Vice President. Dave will pay \$10 of ACTE registration. Dues are normally \$80.

National Policy Seminar—trip to DC. FBLA/PBL will go this year.

Program Management Committee: Sandy Warning reported that the Program Management Committee meets 4 times per year. Approximately 20 members including educators and business leaders. The Program Management Committee also organizes summer workshops. This year they have also received approval for an insurance institute and oracal academy. The program is completely funded by the Griffith insurance. The majority of the Oracle training is paid by Pella Corporation.
